Booking: The mare is booked by name. The booking is valid to the mare named and may not be transferred without the consent of the stallion owner. This booking is for the 2026 breeding season only (February 15, 2026 – August 15, 2026). The mare must be re-booked for each additional service year. Stallion owner reserves the right to reject any mare at their discretion. The booking fee is not included as part of the stud fee. The booking fee is nonrefundable under any circumstances and must be paid and returned with his contract for the mare to be booked. Please contact Kati Silvers at 864-554-4674 to pay the booking fee. Stud Fee: The stud fee must be paid in full before the mare will be accepted at Silvers Stables. The stud fee includes up to three live covers. At the completion of one live cover, the responsibilities of the stallion owner, stallion, and Silvers Stables in fulfilling their responsibilities to the agreed upon breeding and to the stud fee are fulfilled. Any covers beyond three are an additional \$100. No mare shall be bred until stallion contract is returned and breeding fees are paid.

Breeding Season: The breeding season is February 1, 2026 until August 15, 2026. A *Late Breeding Service Arrangement* for special circumstances and only to approved mares can be arranged for an additional \$250.00. This is not guaranteed nor is it encouraged and will be fully at the discretion of Silvers Stables LLC if the service is to be granted. Late Breeding ends on September 30th, 2026. Mare owner understands the later they wait to send the mare for breeding, the less time they have in the Breeding Season for the mare to cycle, breed, and conceive, and therefore, the less time they have at utilizing the Breeding Season for fulfilling the breeding arrangement.

Live Foal Guarantee: The stallion owner guarantees a live foal from the above mating. If the mare aborts the foal or foal dies within 48 hours of birth, the mare owner is entitled to one return privilege. Stallion owner must be notified of the death of the foal within one week and a statement must accompany such notice from a licensed veterinarian or this privilege becomes null and void. This privilege will expire two years from the date of first service to this mare.

Return Privileges: The stallion owner guarantees return privileges if the mare is examined by a licensed veterinarian and found to be barren by 60 days from the date of the last service. If for any reason, the mare is determined by a licensed veterinarian to be unable to conceive, mare owner may substitute another approved mare. This privilege shall expire two years from the date of first service to the mare in this agreement. Any return privileges are conditioned upon payment of all current fees and normal charges and upon the stallion being alive, fit to breed and standing at Silvers Stables. Silvers Stables may provide a substitute stallion if one is available, however, mare owner will not be due a refund of any fees paid after completion of the first service to the mare named above.

Breed Registry: Stallion owner will execute all documents necessary for appropriate breed registry provided that all fees have been paid which are due stallion owner and all terms have been fulfilled.

Dangerous Mare: If Silvers Stables attempts to breed the booked mare and discovers that she is too unhandled or dangerous to breed (pawing handlers, kicking stallion even when she is absolutely ready to breed, and other reasons they may deem unsafe), either for the stallion, the farm, or for the handlers, an approved substitute mare may be sent to be bred in the dangerous mare's place. The original mare's mare care must still be paid in addition to the replacement mare. If a suitable mare is not able to be sent as a replacement, no refunds of any type will be given.

Mare Care and Risk: Mare will not be accepted at Silvers Stables without a properly completed Mare Care Agreement Form in addition to the Booking Fee and Stud Fee. All fees associated with the mare's care are the responsibility of the mare owner, including but not limited to day fees, veterinary care, travel, and farrier fees. Mare owner understands the risks of owning, shipping, breeding, and housing horses and does not hold Silvers Stables, the handlers, the farm, or their staff responsible for any risk or injury to the mare.

Breeding Risk: Mare owner fully understands, authorizes, and assumes the special risks inherent in breeding horses. Mare owner also understands the risk of failure due to many variables and unknown causes and shall hold the stallion owner, Silvers Stables, staff, and the stallion manager harmless from any losses suffered due to any unsuccessful attempt at conception. Mare owner understands that it is the owner's responsibility to get the mare to Silvers Stables in an appropriate amount of time within the Breeding Season or during a mare's cycle for the breeding to be successful.

Dispute: If any dispute arises between the parties, venue and jurisdiction shall lie within the judicial district where the stallion owner resides. In addition to legal relief, a court is hereby authorized to grant injunctive, declaratory or other appropriate equitable relief to enforce both the grant and the limitation of warranties and remedies as set forth by this contract. In any legal proceeding arising out of this contract, the prevailing party shall be entitled to their reasonable attorney's fees and costs of suit, in addition to any other relief granted by the Court. In no event shall damages be awarded for the mare owner's incidental or consequential damages of any kind, including, but not limited to, lost profits or lost production.

Stall Boarding provided at a rate of \$17.00 per day for mare, or \$22.00 per day for mare and foal. Pasture boarding is available at \$10.00 per day for mare or \$15.00 per day for mare and foal. Pasture boarding is limited for mare/foal combos. If a mare is difficult to catch or for any other reason needs a small lot, that can be arranged with a slight increase in pasture board (dependent on need of horse). Any supplements are to be provided by the mare owner. Silvers Stables will provide hay 2 times per day and grain 1-2 times per day as requested for stalled horses. Pasture horses have unlimited access to hay. Each collection/cover will be \$350.00. Mare owner is responsible for all 3rd party fees incurred during the mare's stay including, but not limited to veterinary and farrier services. If you would like these billed directly by the vet, please let us know BEFORE your mare arrives, so you are in their system.

Mare Owner certifies the named mare is up to date on her vaccinations, including rabies. A copy of the mare's negative Coggins and vaccinations must accompany her or be sent ahead via mail or email.

Hold Harmless Agreement: Mare Owner fully understands, authorizes and assumes the special risks inherent in breeding horses and agrees to hold Silvers Stables and their employees harmless for any illness, injury, or death to mare and/or foal while in their possession. Mare Owner also understands the risk of failure due to many variables and unknown causes and shall hold the stallion owner, Silvers Stables, and their employees harmless from any losses suffered due to any unsuccessful attempt at conception.
